NEW YEAR - CONTINUED VISION

On Tuesday, November 19th, Mayor Bridge Littleton provided his annual "State of the Town" address and highlighted the accomplishments of the Town during the past year, focusing on items that protect and preserve the quality of life of Middleburg residents.

Specific accomplishments during 2024 included:

- Adoption of R-2 Zoning Ordinance changes to limit impacts of new construction on established neighborhoods;
- Reduction in Speed Limit through Town to protect residents, visitors, and all pedestrians;
- Appropriate application of limitations on short-term rentals to ensure compatability with neighborhoods;
- Addition of community events focused on residents and locals, including the inaugural Middleburg Day;
- Completion of key utility projects to protect health and safety of our community;
- Continued fiscal strength and fiscal health, adding to the Town's fiscal reserve and investing in key infrastructure projects;
- Hiring of key personnel and investment in employees, specifically in the Police Department.

Mayor Littleton further emphasized the Town Council's commitment to its overarching strategic purpose, vision, and mission:

Overarching Strategic Purpose: To preserve and promote strong community in the face of rapid and continuous change around us and to us. **Vision**: To be a unique, historic, rural town; always enduring, vibrant, and caring.

Mission: To provide purposeful, accountable leadership; and to deliver quality, cost-effective town services.



BACKFLOW PREVENTION AND CROSS-CONNECTIONS

The Town of Middleburg is mandated by the Virginia Department of Health and by Town Code to ensure that proper devices are installed and inspected annually at properties that could have the potential for "backflow" or "cross-connection" to the Town's water supply.

Situations that require a backflow prevention device may include: commercial kitchen; swimming pool; lawn irrigation system; medical or dental office; other source of water onsite (private well); potential for customer water to re-enter the potable water system, such as through unintentional siphoning or backwards pressure; or yard hydrants.

In early 2025, residents will receive a mailer indicating they may be required to have a backflow prevention device.

TOWN NOTES:

TOWN WATER MAIN FLUSHING PROJECT:

In an ongoing effort to improve water quality, the Town's contractor will be conducting water main flushing in the new year. This effort will focus on removing any sediment (from naturally occurring elements iron and manganese) that may have built up in our water mains. With the repairs to Well 4, the Town's water quality should improve greatly and instances of discolored water should be minimal once the flushing process is complete. Please contact the Town Hall or visit the Town website for details on timing of the flushing process.

CLEARING SIDEWALKS AFTER SNOWSTORMS:

The Town reminds residents and tenants that individual property owners are responsible for clearing sidewalks in front of their property after a snowstorm.

Specifically, properties in the commercial area of town are required by Town Code to have sidewalks cleared within 6 hours of the end of a storm, or by noon the next day, if snow falls overnight.

We want to ensure that Middleburg remains a safe and accessible town for everyone, and keeping sidewalks clear is an important way to keep pedestrians safe!
