


## RESTRICTIONS ON SERVICE


-Refuse collection for residential customers is limited to the equivalent of no more than two (2) refuse containers, neither to exceed 90 gallons, per week.

-Apartments, commercial & lodging establishments whose volume of refuse exceeds four 90-gallon containers per week shall be required to contract for dumpster or other collection service through a private trash hauler.



-Restaurants may be required to contract for dumpster service for refuse, to be dumped at least one per week, through a private trash hauler.

## SPECIAL AND/OR BULK COLLECTIONS



In the event you have a special item that is too large, bulky or heavy to be handled in the normal curbside refuse collection, please contact the Town the week prior to your desired Wednesday collection date.

Special collections may include the following items:

- Furniture
- Appliances (\*\*NON-refrigerant containing) such as: dishwashers, stoves, dryers and clothes washers
- Water heaters, toilets, sinks & similar items
- \*\*\*Refrigerant-containing appliances such as refrigerators, freezers, air conditioners and dehumidifiers cannot be collected due to special disposal requirements. Please contact the Loudoun County Landfill for info on disposal of these items.

### REGULATIONS

It is the policy of the Town that public and private property be kept free of refuse to the maximum extent possible and to encourage recycling in order to promote the health, safety and welfare of the citizens.

# COLLECTIONS

---



The Town contracts with a private vendor to pick up trash, recycling and yard waste in the Town limits.

Collections occur on Wednesday mornings beginning as early as 6:00 a.m. During holidays or when inclement weather prohibits collection, collection will occur on the following business day.

Items may be placed at the curbside for collection no earlier than 3:00 p.m. on Tuesdays and must be out no later than 5:00 a.m. on Wednesdays. Empty refuse & recycling containers shall be removed from the curbside by the evening of the collection day.

## RECYCLING

The following items may be recycled and can be co-mingled:

-Newspapers, magazines, phone books, paperback books, catalogs, mail, mixed paper, cardboard, paperboard, cardstock, brown paper bags, non-metallic wrapping paper and shredded paper.

-Acceptable PETE and HDPE plastic containers #1-7, including bottles, jars, jugs, wide-mouth tubs and trays, aluminum, steel, tin, bi-metal cans, foil, glass bottles and jars.

Recycling containers, when full, may not weigh more than fifty (50) pounds.



All items must be free of food and other non-recyclable materials.

It is requested that cardboard boxes be broken down.

Recycling receptacles must be strong enough to withstand handling and must prevent the scattering of their contents.

## YARD WASTE

Organic yard waste may be placed in biodegradable containers or placed loose in trash cans (must have a “yard waste” sticker) with handles for lifting and tightly fitted lids.

Brush must be bundled and tied with string or twine. It cannot be longer than three (3) feet or have a diameter of more than three (3) inches.

Yard waste may not exceed twenty-five (25) pounds in weight per bundle or container.
